When, within the scope of the FSC certification, substantial remarks are made, these remarks shall be communicated with the applicant. When the certification process is finalized the summary of the certification report, including the findings of the stakeholder consultation is made public on the FSC webpage ww.info.fsc.org under certificate holder record
